VENUE: Surrey Sports Park, Guildford. The pool length is 25m, 8 lanes, and will be equipped with electronic timing with full display and anti-wave lane ropes. Backstroke ledges will be available. Continuous warm up and swim down facilities will be available throughout the meet.

AFFILIATION: Guildford City S.C. is affiliated to Swim England South East Region. The meet will be held under Swim England Laws and Regulations and Swim England Technical Rules of racing. The meet is licensed at Level 2 under Licence number: 2SE240742

AGE GROUPS: Age groups are: 10 & 11, 12, 13, 14, 15, 16, 17 and 18+.
Ages as at 23.59HRS 31st December 2024

COMPETING CATEGORIES:

Swimmers will be required to swim in one of two groups, Female or Open/Male swimmers.

The Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category, a swimmer confirms that their birth sex is female.

EVENTS: Events will consist of 50m, 100m and 200m of all four strokes, 400m, 800m and 1500m freestyle and 100m, 200m and 400m Individual Medley (10/11 year olds not eligible for 400m IM, 1500m and 800m Freestyle.)

There will be a Junior Final (ages 15 and below) and a Senior Final (ages 16+) for all 50m, 100m and 200m events. All remaining events will be heat declared winner in each individual age group.

If there are less than 8 swimmers competing in a final, the Promoter may take the decision not to run it.

Events will be seeded into heats from submitted times with slowest heats swum first. Heats will be swum in a spearhead formation. In events where there are finals, the last three heats will be cyclically seeded.

It is the responsibility of swimmers to report to the stewarding area in sufficient time for each event. Guildford City Swimming Club cannot be held responsible for any swimmer missing the start of their heat.

ENTRIES: The Opening date for entries is: **19th October 2024**

The Closing date for entries is: **2nd November 2024**

Entries must meet the published minimum qualifying standards and all such entries will be considered. All entry times must be verifiable from the British Swimming Rankings.

The objective of the Meet is to provide opportunities for swimmers for fast short course swimming at the end of the Short Course season.

Entries may be restricted to keep the session times within appropriate timescales. The acceptance of competitors will be based on fastest times submitted by age group. Details of accepted and rejected entries will be posted on our website as soon as possible after the closing date. Rejected entries will be refunded.



There will be no refunds for withdrawals after the closing date other than withdrawals for medical reasons that are accompanied by the appropriate certification.

If the meet is oversubscribed, a reserve list will be operated to insulate against the effect of late withdrawals and to maximize opportunities for swimmers to participate. Swimmers whose entries are initially rejected will be invited to apply for inclusion on the reserve list. Anyone on the reserve list must be within the qualifying times. The period for application will close 5 days after publication of the initial list of accepted and rejected entries. The reserve list will be seeded based on a first come first served basis. If swims become available, they will be offered to those highest on the reserve list. Swims for those accepted reserve applicants cannot be guaranteed. Entry fees from reserves that do not swim at the Meet will be refunded after the Meet.

The submission of entries, either electronically or via entry form indicates acceptance of the Meet Conditions.

Club entries with short course times (long course conversions will be accepted) should be submitted using the Hy-tek electronic entry file available to download via www.gcsc.co.uk.

Individual Entries

Guildford City will no longer accept individual entries from external Club Members ages 17 and under, due to the new Swim England policy regarding Team Manager/Coach & Chaperones. **However, should another Club entering the open meet be willing to assume responsibility for the swimmer at the open meet, we would require both the Visiting Club and the Parent/guardian of the swimmer to complete and sign a form setting out their responsibilities. The individual swimmer must also have a responsible adult who is not poolside acting in loco parentis at the open meet. Please contact: claire.walsh@gcsc.co.uk for more information. If the relevant criteria has been met the forms will be sent via our Adobe Software. They can be completed and signed using a mobile phone.** Otherwise, we will only accept bona fide Club entries and individual entries for swimmers aged over 18 years old. Please see Swim England's Policy regarding supervision of swimmers - Coaches / Team Managers and Chaperones.

OVERSEAS CLUBS: The Promoter reserves the right to give preference to Club entries from overseas clubs where the pre- booking of flights is required to travel to and from the Meet. All entries must meet the published qualifying times, proof maybe requested. Application must be by email to the Meet Administrator on claire.walsh@gcsc.co.uk The Promoter recommends that no travel or accommodation arrangements are confirmed until the club receives written confirmation of entry. GCSC cannot be held responsible for any costs so arising.

ENTRY FEES: Entry fees are **£9.50 per event (£15 for 800m and 1500m events)**. Cheques should be made payable to Guildford City Swimming Club.

Programmes will be available to download from the website prior to the meet.

POOLSIDE PASSES: Poolside passes for Coaches are available at a cost of £25 per day or £40 for the weekend. Poolside passes include admittance to all sessions, programmes, food/refreshments and results.

A free poolside pass will be provided to any club entering 30 swimmers or more or providing licensed officials for all 4 sessions.



STRICTLY NO MOBILE DEVICES IN CHANGES ROOMS: With effect from 3 January 2024, Swim England has changed the rules about changing rooms. Any use by any person of a device that can connect to the internet is prohibited from the point of entry to a changing room until exiting the changing room. In practice this means that any device must be in a bag or pocket - it must not be visible. **There are no exemptions to this rule.** If you believe there is a valid medical reason for using a device in the changing room; this should be raised with the Guildford City Swimming Club welfare officer.

TOP SWIMMER PRIZES: Cash prizes will be awarded to the top female and open/male swimmer in junior and senior age groups. This will be determined by the swimmers who achieves the highest FINA points in an individual event. Cash prizes will be awarded at the end of session 4.

SPECTATORS: There is no charge for entry for spectators. Spectator seating however, is limited at Surrey Sports Park and admission for Spectators may be restricted accordingly. Parking is free in the nursery carpark. Restricted parking (3 hours Max) is available in the main carpark. Please be advised the park and ride is not managed by the SSP.

SAFEGUARDING THE RUNNING OF THE MEET: All clubs submitting entries are requested to assist in the running of the meet by supplying details of any Licensed officials who are willing to assist at this Gala.

OFFICIALS: Name and contact details for officials should be completed by the person responsible for submitting the entries and forwarded to gcscofficials@hotmail.com

SIGN IN: This is a **SIGN IN** gala. It is the responsibility of the swimmer to sign in for events they wish to compete before warm-up of the corresponding session. Failure to sign in will result in eviction from the race. The sign in desk will be located near the entrance to the changing village.

WARM-UP: Swimmers and coaches must ensure that they take no action that would endanger themselves or others. Sprint lanes will be announced.

SWIM DOWN: A swim down pool will be available for use throughout the duration of the event. Swimmers are requested to respect other competitors in and around the surrounding areas whilst using this facility. The instructions of the pool lifeguard and/or Guildford City SC Meet Management Staff must be followed. Guildford City SC Meet Management Staff and the Surrey Sports Park Management reserve the right to close this facility.

AWARDS: Medals will be awarded to the top three placed swimmers in each age group in the heats of each individual event. Additionally, awards will be given to the first 3 swimmers in each final.

There will be a trophy awarded to the Top Visiting Club.

Presentations will not be made. Awards should be collected from the awards table.

S15 SWIMMERS: Upon request of entry, a secondary strobe light is available at this event for S15 swimmers,

HEALTH AND SAFETY: Everyone attending the event must familiarise themselves with the location of the emergency exits, which must be kept clear at all times. Everyone is asked to observe all normal precautions in the pool area and when moving around The Surrey Sports Park.

Swimmers must not leave poolside unless they are dry and wearing clothes and shoes.

BEHAVIOUR: The Guildford City SC Open Meet Management Staff and the Surrey Sports Park management reserve the right to remove any person from the pool area, whose behaviour is either against the pool rules or the efficient running of the meet.

SECURITY: Persons are requested not to leave belongings unattended. As space at Surrey Sports Park is limited, swimmers will not be allowed to bring large bags on poolside. Belongings should be placed in the lockers in the changing area (£1 charge which is refunded on leaving). Guildford City SC nor The Surrey Sports Park Management will be held responsible for loss of personal property.

DATA PROTECTION: Entries and results will be managed via computer and available via the internet. By submitting entries, consent is thereby given, as required by the Data Protection Act, to the holding of personal information on a computer. Personal data, including submitted and recorded times, will be available during the meet.

Any matter not covered by these conditions or by Swim England laws and regulations or technical rules of racing will be at the Promoter's discretion.
